The post of Treasurer has been vacant since March 2022 and these duties have been undertaken jointly by the Chair and Secretary.

### **Objectives and activities**

Inverurie Music was established in 1999 due to local enthusiasm for high quality live music in the classical tradition performed in rural settings and to a variety of age groups. In addition to promoting concerts, Inverurie Music organises other musical activities such as workshops run by professional musicians, and an award scheme for local young musicians which was established in 2019. Inverurie Music became a charity in 2014 and since then has continued to develop its charitable purposes to benefit the local community.

With the support of Chamber Music Scotland and other funding bodies, and in collaboration with others such as the University of Aberdeen and other local music societies in the area, Inverurie Music contributes to the thriving music society scene in Scotland. It has established a strong ethos of welcoming musicians to the area, especially those who are starting out in their professional careers. Strengths of the organisation include the hard work of the volunteers, the warm hospitality offered to both artists and audiences, and the high-quality performances the charity has been able to bring to Aberdeenshire, often introducing new or unusual pieces to the audiences.

# **Charitable Purposes**

To advance the arts by improving, developing and maintaining appreciation of the art and science of music in all its aspects by the presentation of public professional recitals in Aberdeenshire.

To advance the education of the general public, school pupils and amateur musicians in Aberdeenshire and Aberdeen City.

### **Achievements and performance**

#### **Concert Season 2022-23**

The concert season 2022-23 comprised seven recitals, beginning and concluding with solo piano recitals which could not have been more different. In October 2022, the young Italian/French pianist Ida Pelliccioli presented a beautifully crafted, introspective, and emotional programme, whilst the highly experienced Janusz Piotrowicz transported the audience to another place altogether with his renditions of Chopin, Liszt, et al in May 2023.

In between these, there was a wonderfully diverse mix of performances. In November 2022, the virtuosic young trombone quartet Bone-Afide proved extremely popular, combining fun with proficient playing, and attracting a large and highly appreciative audience. The delightful pianist Duncan Honeybourne stepped in at short notice in February 2023 when the scheduled Trio Orfeo had to cancel due to illness. Duncan presented a weighty programme, which included the world premiere of "National Anthems" composed by Inverurie Music trustee Phillip Cooke and concluded with Liszt's transcription of Schumann's "Widmung" – an encore for Valentine's Day. In early March we saw the return of the Tim Kliphuis Trio who delighted the audience with their incredible musicianship and their Gypsy Jazz style. The number of young people attending this concert was noticeable. Later in March, Apollo's Cabinet (an early music ensemble comprising harpsichord, voice, recorder, Viola da Gamba and theorbo) presented a performance with a storyline, a mix of Baroque music played with virtuosity on period instruments, coupled with dramatic sketches. It resembled a pantomime for Springtime, a refreshing performance which resulted in audience members leaving with huge smiles on their faces. April saw the return of Inverurie Music favourites Lana Trotovšek and Maria Canyigueral, this time accompanied by flautist Boris Bizjak. Their programme included works by Prokofiev, Schubert, and Inverurie Music Trustee John Hearne's "Six Tableaux".

Inverurie Music is grateful to the Tunnell Trust which supported two concerts during this season – Bone-Afide and Apollo's Cabinet.

In addition to the main concert series, a fundraising concert in aid of the Inverurie Music Award Scheme was held in June 2023. This featured young musicians who had received awards in previous years as well as the Nova Quartet (a newly-formed local string quartet). Sadly, this concert was not well attended but it proved to be a delightful, light-



hearted evening. The event was supported by generous donations from several local businesses which gave a boost to the award scheme fund.



#### **Music Education**

### Workshops and Masterclasses

Inverurie Music organised two Strings Workshops at Kemnay Church Centre, led by Aaron McGregor (Lecturer in Music Performance at the University of Aberdeen) and these were popular and well-attended. Masterclasses/Workshops led by the Tim Kliphuis Trio (violin/guitar/double bass) in March and Lana Trotovšek, Maria Canyigueral and Boris Bizjak (violin/piano/flute) in April took place in the King's Pavilion at the University of Aberdeen. It was pleasing to see a number of young people at both these workshops. The fees for participants were set at a low level in order to encourage participation and this was only possible with financial support from funders such as Chamber Music Scotland and the David and June Gordon Memorial Trust.

#### Inverurie Music Award Scheme

The Inverurie Music Award Scheme was established in 2019 to provide financial support to local young musicians for a variety of musical activities. The fund is generated each year from donations and fundraising events. In 2022, a total of £1,100 was given to young musicians who applied for funding. Awards were made, for example, to help with the purchase of musical instruments, the purchase of recording equipment, and to provide expert tuition for a school brass group.

## Structure, governance and management

Inverurie Music has six Trustees as noted above. Three new board members were elected and welcomed to the board at the Annual General Meeting in October 2022. The post of Treasurer remained vacant throughout season 2022-23.

### **Financial review**

### Treasurer's Report:

The year began with £9,202.15 in the bank account, and ended with £11,594.35.

Subscriptions were offered at a cost of £56 for seven concerts. Single tickets cost £13. Free subscriptions/single tickets were offered to under 25s in full-time education; and those receiving disability or low-income benefits.





### **Future plans**

Concert season 2023 - 2024 is well underway and comprises six concerts. The first workshop, a string ensemble day, ran in November 2023. The workshop season will have four workshops in total – two for strings, and two others for violin/piano and voice/piano. Fundraising has begun for the Award Scheme 2024. In addition, plans are being made to provide performance opportunities for local emerging artists and to commission a new work.

The position of Treasurer, vacant since March 2022, has recently been filled on an 'acting' basis by Phillip Cooke. This is a welcome development and the board is grateful to him for agreeing to this. The board has been strengthened by the return of lan Clark as a member. Ian was Treasurer during his last period on the board and his return is welcome. John Hearne, a founding member of Inverurie Music, has indicated that he now wishes to stand down from the board. Warm thanks are due to John for all his dedication to the work of Inverurie Music for more than 20 years.

Inverurie Music is approaching its 25th anniversary season and plans are in the early stages to mark this milestone.
